2024 Public Policy Priorities

ABC has developed a set of public policy priorities to guide our federal advocacy work. Carrying out this work brings the ABC closer to fulfilling its mission to advance understanding of brain functions to reduce the burden and stigma of brain diseases and conditions in order to improve the lives of impacted people.

This includes individuals with lived experience, their caregivers, those who treat patients, and researchers and scientists studying the brain. Research shows that when we adopt healthier brain habits, cognitive function can often be enhanced or extended. ABC is committed to bringing science-backed brain health approaches to the public, while also encouraging research and dialogue on the responsible use of advances to brain science.

ABC recognizes the burden of illness, injury, disability, and mortality among disproportionately impacted populations. In all we do, the ABC is working toward the elimination of health disparities, whether resulting from race/ethnicity, economic status, advanced age, geographic isolation, or stigma against brain diseases and conditions.

Additionally, the report addresses the FY 2025 appropriations process, highlighting the critical need for sustained and robust investment in biomedical research to support both scientific discovery and the development of new or improved treatments. Through these efforts, ABC reaffirms its commitment to advocating for policies that advance understanding of the functions of the brain, and to reduce the burden of brain diseases and conditions.

Innovation Initiative (ABC12)

In 2017, the ABC established an [Innovation Initiative \(ABC12\)](#), a collaborative program to stimulate private investment in brain-related research, remove regulatory and financial barriers to research, and strengthen the entire R&D system for expedited translation of neuroscience research into life-changing therapies and cures. This ABC advocacy effort is comprised of key stakeholders within the brain community, including patient advocacy groups, professional societies, and industry, collaborating to advance policy positions, legislation, and regulations that will strengthen incentives to invest in neuroscience research – positively impacting brain disorders. This program has provided several resources to the ABC membership, including a guide to navigating [Public-Private Partnerships](#).

ABC continues to recognize the unmet need for the development of products to treat brain diseases and conditions. Innovation is critical to improve the lives of people with these conditions. Federal agencies, like the Food and Drug Administration (FDA), must develop policies that keep pace with emerging brain science and work to advance discoveries, ensuring that individuals with brain diseases and conditions have access to new, safe, and effective treatments and therapeutics.

FDA Neurology Drug Program

ABC plays a leading role in advocating for the [Neurology Drug Program](#), demonstrating its commitment to advancing neurological and psychiatric research, treatment, and care within the United States. ABC leverages its collective voice and expertise to champion this initiative to support individuals living with brain diseases and conditions. Through strategic collaborations with policymakers, healthcare professionals, researchers, and patient advocacy groups, ABC advocates for increased funding for the Neurology Drug Program to accelerate the development and approval of new therapeutics for individuals with brain diseases and disorders.

In April, ABC led a brain community effort and [sign-on letter](#) to the House and Senate to provide \$5 million for the Neurology Drug Program (NDP). In November, ABC circulated a [follow-up letter](#) requesting Congress to include \$5 million for NDP proposed by the Senate Appropriations Committee.

In September, Dr. Rasenick sent a [written thank you](#) to the Senate Appropriations Committee & Ag-FDA Subcommittee for NDP Funding Support.


Total Product Life Cycle Advisory Pilot (TAP) Program

The FDA Total Product Life Cycle (TPLC) Advisory Program (TAP) Pilot is meant to help spur more rapid development and widespread patient access to safe, effective, high-quality medical devices of public health importance. The TAP Pilot is intended to foster early interactions FDA facilitates between device manufacturer participants and non-FDA stakeholders. FDA intends for TAP to help ensure the sustained success of the Breakthrough Devices Program for innovative devices. Through generous grant support from the Dana Foundation, ABC has partnered with the FDA in identifying interested stakeholders in the Neurological and Physical Medicine space. ABC facilitates engagement between brain communities and other stakeholders within the FDA TAP Pilot. As a liaison and convenor, ABC ensures a more meaningful range of stakeholders, and the lived experiences of patients and their families, are included in the important conversations and decision-making processes of TAP.

A number of stakeholders have become collaborating partners in the TAP Program by providing organizational profiles to educate FDA on their area(s) of potential interest, engagement ability/limitations, communication platforms, membership base, and other areas, to facilitate potential outreach on relevant Breakthrough Devices.

The BRAIN Initiative is a collaborative effort among many government agencies and private sector partners.

ABC Advocates for the BRAIN Initiative

Our advocacy includes community-wide sign on letters sent to the appropriate House and Senate members in charge of appropriations; providing written testimony; working with our Congressional Neuroscience Caucus champions in commenting on this important initiative; and conducting meetings with appropriators.

The American Brain Coalition, partnered with Friends of All of Us Research program, circulated a letter encouraging Congress to support the funding level proposed by the Senate Appropriations Committee for both of these important programs.


Financials


2024 Revenue


